This Easy Read survey will ask you what you think about the plan to deal with domestic and sexual abuse in Northern Ireland.





The **Department of Justice** works to keep everyone safe by making sure people take responsibility when they break the law.


What we are doing

Domestic and sexual abuse



Domestic abuse is when you are harmed by someone you are in a relationship with or by a family member.



Sexual abuse is when you are made to do things that involve your body that you don't want to do.



Abuse is when someone hurts you or treats you badly.




Domestic and sexual abuse are always wrong.




It is not your fault if you suffer from domestic or sexual abuse. It is the fault of the person who is abusing you.

Domestic abuse

Domestic abuse can happen between:



- partners.



- people who used to be partners.



- boyfriends and girlfriends.




- close family members.



Domestic abuse can be where someone:

- attacks you, or is violent towards you.



- makes you do sexual things you don't want to do.

Domestic abuse can also be where someone:



- is controlling you and not allowing you to do what you want.



- stops you seeing your family or friends.



- threatens you and makes you feel frightened.



Domestic abuse is a crime. It is against the law.



Sexual abuse

Sexual abuse can happen to anyone.

Sexual abuse happens in different ways, like when a person:



- Says inappropriate things to you that you don't want to hear.



- Shows you inappropriate things that you don't want to see.




- Touches your body in an inappropriate way, or makes you touch them.



The plan to deal with domestic and sexual abuse



We want to stop domestic and sexual abuse from happening so that people can live without fear of being abused.



To help us understand what we need to do, we heard from:


- Victims of abuse.

They helped us to come up with ideas to stop domestic abuse and sexual abuse.




In early 2022, we asked people what they thought of our ideas.



We also looked into how our ideas will affect different people.



This was to make sure we deal with abuse in the best way for everyone.



All of this has helped us to write a plan to deal with domestic and sexual abuse over the next 7 years.




The plan is called the 'Domestic and Sexual Abuse Strategy 2023 to 2030'.

The plan sets out the 4 main areas of work to deal with domestic and sexual abuse:



1. **Partnership**

This is about everyone working together to deal with abuse.



2. **Prevention**

This is about stopping abuse from happening.



3. **Support**

This is about making sure victims of abuse can get the help they need, when they need it.



4. **Justice**

This is about the justice system being better at dealing with cases of domestic and sexual abuse.







The way we work will be based on what victims tell us is right for them.






Prevention





We want to understand why many victims do not report domestic and sexual abuse, so we can help them to do it.









What happens next



When we have decided on the final plan, we need to make sure it works to deal with domestic and sexual abuse.



To make sure the final plan works, we will:

- Set up a group to manage the plan called the 'Strategic Delivery Board'.



The Board will include people from different government departments, organisations, the police and services who support victims of abuse.



The Board will meet every 3 months and tell the government about how the plan is going.



We will also:


- Write a plan each year for what needs to be done that year.



- Collect information as we go through the plan to check it is working and what needs to improve.



- Make sure the money we have available is spent on the right things.



- Ask people to tell us what they think about how the plan is going, as we are working through it.


